- 6. Any bid received by the Employer after the deadline for submission of bids will be returned unopened.

- 7. Any bid not accompanied by an acceptable Bid Security shall be rejected by the Employer as non-responsive.
- 8. FIEDMC may reject all or any bids subject to relevant provision of Punjab Procurement Rules 2014 (PPR-2014).
- 9. Bids/ tenders with any conditions shall be rejected.
- 10. Bids shall be valid for a period of 01 month
- 11. Bids shall be quoted in Pak Rupees and payment shall be in Pak. Rupees.
- 12. Time for Completion of Work shall be one month from the date of receipt of Letter of Acceptance, which shall be issued to lowest evaluated bidder after the evaluation of bids.
- 13. Bid Security furnished by the lowest evaluated bidder shall be treated as Performance Security and shall be returned after the issuance of Completion Certificate, which shall be issued within 07 days from the date of Taking Over of the Works. Bid Security of the unsuccessful bidders shall be returned after the evaluation of bids.
- 14. All Works shall be supervised by the Consultant, M/S Osmani & Company/FIEDMC.
- 15. Payment shall be made by the Employer as per the amounts certified by the Chief Resident Engineer, subsequent to the submission of bill by the Fabricator/Contractor. Payment shall be made within seven days of the receipt of bill from Chief Resident Engineer.
- 16. Site will be handed over to the Fabricator/Contractor at the issuance of Letter of Acceptance.
- 17. All Works shall be to the satisfaction of CRE/FIEDMC. PPRA-2014 shall apply; these are available at http://ppra.punjab.gov.pk/downloads
- 18. All steel works shall be coated with red oxide and two coats of best quality enamel paint as approved by CRE/FIEDMC
- 19. All the materials' specifications shall be to the satisfaction of CRE/FIEDMC and as approved.
- 20. Welding electrodes may be the locally manufactured electrodes subject to the approval of CRE/FIEDMC.
- 21. Fabrication, Welding, Installation, Completion shall be to the satisfaction of CRE/FIEDMC.
- 22. The Fabricator/Contractor shall be responsible for providing labor for each and every works regarding the completion of Works.
- 23. All costs are required to be included in the rates quoted by the bidder.
- 24. No escalation shall be admissible on any ground and the price(s) shall remain fixed.
- 25. The Fabricator/Contractor shall provide for all parts of the Works to be completed in every respect.
