FIEDMC (Purchaser) hereby invites sealed bids from the suppliers/firms/authorized dealers having enlistment with the tax authorities; proof of it must be appended with the Technical Bid. All Bids must be submitted in two main envelopes, one marked "Technical Bid" as per Sub-Clause 11.1 of Bidding Data & the invitation(s) and other marked "Financial Bid".

Alternative Proposals may be given by the Bidder but separately, Technical as well as Financial, and marked clearly "Alternative Proposal". This should be as per Clause 20 of the Instructions to Bidders.

Bidders may obtain further information from, inspect the Bidding Documents from the PPRA Punjab and/or FIEDMC websites. A complete set of Bidding Documents may be purchased by an interested bidder on submission of a written application from the office of the undersigned upon payment of a non-refundable fee of Rs. 10,000/- (Rupees Ten Thousand Only) till 30.06.2016. The Suppliers/Firms/Authorized Dealers who have already purchased bidding documents need not to purchase again. Revised/Amended Bidding Documents will be sent to them at their address.

Technical Bids must also be accompanied by a Bid Security in the name of FIEDMC, in the amount of not less than Rs. 2,500,000/- (Rupees Two Million Five Hundred Thousand only) in the form of Deposit at Call or CDR or Bank Draft or Pay Order or a Bank Guarantee issued by a Scheduled Bank in Pakistan. Any bid not accompanied by an acceptable Bid Security shall be rejected by the Employer as non-responsive as per Clause IB.19.3 of the Instructions to Bidders.

The bids must be delivered to the Office of the undersigned at or before 1500 hours, on 25.07.2016. Any bid received by the Employer after the deadline for submission of bids will be returned unopened to such bidder as per Clause IB.25.1 of the Instructions to Bidders.
