1. Repair and Maintenance Works of Value Addition City, near Khaurriawala, Faisalabad; Contract No. VAC-014; the bidders must have PEC Category & Code as C-4 or above with CE-01 & CE-10; Single Stage Single Envelope Bidding Procedure; Cost of Bidding Documents Rs. 5,000/- (Rupees Five Thousand Only) (non-refundable); Bid Security: 02% (Two Percent) of the Bid Price.
2. Sewerage and Water Supply Lines along Main Arterial Road in Phase-II of M-3 Industrial City, Near Sahianwala Interchange M-3 Motorway, Faisalabad; Contract No. FIC-030; the bidder must have PEC Category & Code C-3 or above with CE-09 & CE-10; Cost of Bidding Documents Rs. 10,000/- (Rupees Ten Thousand Only) (non-refundable); Bid Security: Rs. 04 Million (Four Million only); Single Stage Two Envelope Bidding Procedure.
3. Asphaltic Wearing Course of Main Arterial Road including Road Fixtures / Marking at M-3 Industrial City, Near Sahianwala Interchange M-3 Motorway, Faisalabad; Contract No. FIC-031; the bidder must have PEC Category & Code C-2 or above with CE-01 & CE-10; Cost of Bidding Documents Rs. 10,000/- (Rupees Ten Thousand Only) (non-refundable); Bid Security: Rs. 10 Million (Ten Million only); Single Stage Two Envelope Bidding Procedure

Bidders may obtain further information from, inspect at PPRA Punjab and/or FIEDMC websites and acquire the Bidding Documents from the Employer's Office. A complete set of Bidding Documents may be purchased by an interested bidder on submission of a written application to the Employer's Office and upon payment of a non-refundable fee as stated hereinabove against each Work, in a period from 06.12.2016 to 20.12.2016.

Bids for the Works at Sr. No. 2 & 3 must be submitted in two main envelopes, one marked "Technical Bid" and other as "Financial Bid". Technical Bid must be accompanied by an acceptable Bid Security in the amount as stated hereinabove against each Work. Bids must be delivered at the Employer's Office at or before 1500 hours, on 05.01.2017.

Any bid received by the Employer after the deadline for submission of bids will be returned unopened to such bidder. Any bid not accompanied by an acceptable Bid Security shall be rejected by the Employer as non-responsive.

Bids will be opened at 1530, 1600 and 1630 hours respectively on the same day, in the presence of bidder's representatives who choose to attend at the below stated address. Date of opening of Financial Bids of technically qualified bidders shall be notified at a later date after Evaluation of the Technical Bids for the Works at Sr. No. 2 & 3.

NOTE: The bidders already purchased bidding documents need not to purchase afresh. Bidding Documents may be issued to them without fee; however, such issuance shall be upon written application from such bidder.
