The documents shall be issued to those bidders who will furnish, along with the application, valid PEC enlistment in the relevant category and codes. Bidding Documents shall not be issued on the Bid Submission Date.
3. Bids must be submitted in two main envelopes, one marked "Technical Bid" and other as "Financial Bid" under Single Stage Two Envelope Bidding Procedure

All bids must be accompanied by a Bid Security in the amount of not less than 2% of the estimated value of the Works of Rs. 350,000,000/- and must be delivered to Office of the Chief Executive Officer, FIEDMC, 1<sup>st</sup> Floor, FCCI Complex, East Canal Road, Canal Park, Faisalabad, at or before **1530** hours, on 18.10.2019.
5. Any bid received by the Employer after the deadline for submission of bids will be returned unopened.
6. Any bid not accompanied by an acceptable Bid Security shall be rejected by the Employer as non-responsive.
7. Technical Bids will be opened at **1600** hours on the same day, in the presence of bidder's representatives who choose to attend at the same address. Date of opening of Financial Bids of technically qualified bidders shall be notified at a later date after Evaluation of the Technical Bids.
