The documents shall be issued to those bidders who will furnish, along with the application, copies of valid PEC enlistment with Project Profile Code stated hereinabove, Registration with Income Tax Department, Registration with PRA, Registration with SECP or Registrar of Firms, JV agreement if applicant is JV. For JVs, proportions in JV agreement for all JV partners shall be the basis for all criterion. Bidding Documents shall not be issued on the Bid Submission Date.
- Single Stage Two Envelopes Bidding Procedure shall be used. The deadline for receipt of Technical and Financial Proposals is 1530 Hrs. on 06.02.2020. Technical Proposals shall be opened on the same date at 1600 Hrs. as stipulated in Sub-Clause 4.6 of the Instructions to Bidders whereas opening of Financial Proposals will be in accordance with Sub-Clause 5.5 of the Instructions to Consultants (ITC).
