PRE-CONDITIONS

These pre-conditions are an undertaking to be filled and signed by the Applicant;

1. Application Procedure

- a. Application forms are available from FIEDMC office at a cost of Rs. 1,000/- or can be downloaded from the website. (A fee of Rs. 1,000/- will have to be deposited at the time of submission of application form).
- b. Overseas applicants can download the forms from FIEDMC website and submit to the marketing department at the company address given at the end of the form.
- c. Plots will be allotted on First Come-First Serve basis to the applicants. (subject to availability)

2. General Conditions for Applicants:

- a. Submission of an application does not render entitlement to the right of allotment.
- b. All applications will be accommodated according to the environmental compatibility of the industry in the respective zones in M3IC.
- c. FIEDMC reserves the right to reject any application without assigning any reason whatsoever.
- d. Any change in nature of business shall be permissible only after obtaining No Objection Certificate (NOC) from FIEDMC.
- e. The applicant(s) undertake(s) that the instant pre-conditions and By-laws framed by FIEDMC, as amended from time to time, shall be binding on him/her and shall be complied with including all environmental by-laws / regulations.
- f. Any false or misleading information/statement may result in the rejection of application and/or cancellation of allotment at any stage.

Please Note:

- 1. Connections of utility services shall be obtained by allottee from the concerned Utility Service Provider / Department.
- 3. In some cases actual size of plot may vary as mentioned on the map. Final instalment will be charged according to actual plot measurements.
- 4. All payments will be made in the name of FIEDMC through Demand Draft, Pay Order or Cross Cheque.
- 5. Provisional allotment letter will be issued on receiving down payment of plot and Allotment Letter will be issued on full payment of plot.

Partnership, Firms or AOPs

- i. Partnership Deed; (In case of two or more persons applied for purchase of land)
- ii. An undertaking to meet financial liabilities of firm and name(s) of partner(s) authorized to Sign documents;
- iii. Resolution of Partners regarding purchase of plot;
- iv. NTN Number if any;
- v. Undertaking that the firm has a clean bank record:
- vi. Detail of any money decree against the Partnership, Firm or AOP;
- vii. Copy of NIC of the authorized partner(s).
- viii. Registration with local Chamber of Commerce (company already register at some other chambers should also get registered with Local Chamber of Commerce).

Note:

- o Expatriate Pakistanis/Foreign Nationals are required to provide copy(ies) of valid passport(s).
- o All above said documents are mandatory required to be attached with application form.
- o All undertakings should be provided on stamp paper/company letterhead
- o Failure to submit any prescribed document(s) will make the application liable to rejection.
- o Only NIC(s) issued by NADRA will be entertained. Applicant(s) possessing old NIĆ(s) should submit copy of receipt(s) issued by NADRA for issuance of computerized NIC(s) along with copy of old NIC(s).



3. In Case of Default

4. Operational Schedule:
