All bid must be submitted in two main envelopes, one marked "Technical Bid" and other marked "Financial Bid". Bidding Documents complete in all respects must be submitted at the address given below on or before 07th June, 2021 at 1330 Hrs. Technical Bids will be opened on the same date at 1400 Hrs. in the presence of bidder's representatives who choose to attend at the below stated address, followed by opening of the Financial Bids of Technically qualified bidders on the same date.

The Services will be awarded to lowest evaluated responsive bidder. Punjab Procurement Rules 2014, together with amendments, shall apply. Bids/ tenders with any condition shall be rejected. Any bid received by the Employer after the deadline for submission of bids will be returned unopened.

25% Payment after Evaluation of Technical Bids submitted by the Constructors (Bidders)

25% Payment after Evaluation of Financial Bids submitted by the Constructors (Bidders)

50% Payment after issuance of LOA to the Contractor by the Client.

Sub-Head C

** The Consultant will deploy at-least the following personnel as per the requirements of the Works at Site for the proper and efficient supervision of the Works and for the Services as envisaged herein; the consultant may deploy more staff as per the needs/requirements of Works; remuneration, nevertheless, shall be as stated herein above for the Services. Site Facilities like transport, office, computer, telephone, single resident etc. will be given to the Consultant through the construction Contract.
