- Proof of two similar works executed during last five years.
- Affidavit on the stamp paper (duly notarized) that the bidding firm is not black listed by any Procuring Agency (Govt. or Semi-Govt. Departments, Autonomous bodies, International Organization and any Client/ Employer, DHA or Cantonment in Pakistan) alongwith List of any present or past litigation of the Bidding Firm with any Procuring Agency, (Govt. or Semi-Govt. Departments, Autonomous bodies, International Organizations or any other Client/ Employer). If no litigation than "NIL LITIGATION" shall be indicated on the same Affidavit.

Bidders may obtain further information from, the Bidding Documents available on PPRA Punjab and/ or FIEDMC websites. A complete set of Bidding Documents may be purchased by an interested bidder on submission of a written application (duly attached with all eligibility documents) from the office of the undersigned upon payment of a non-refundable fee of **Rs. 3,000/-** (Rupees Three Thousand Only). Application for purchase of Bidding Documents with incomplete documents shall not be entertained. Bidding Documents shall not be issued on the Bid Submission Date.

The Bids must be accompanied by an acceptable Bid Security (Bank Guarantee/ CDR) in the name of FIEDMC. Any bid not accompanied by an acceptable Bid Security shall be declared non responsive. Any bid received by the Employer after the deadline for submission of bids will be returned unopened to such bidder.

Bidding Documents complete in all respects must be submitted at the address given below on or before the **25th October 2021 at 1500 hrs.** Bids will be opened on the same date at **1530 Hrs.** in the presence of bidder's representatives who choose to attend at the below stated address.
