- License of Pakistan Engineering Council (PEC) in Category C-3 or above with Specialization Codes of CE-10, EE-04 & EE-05 valid for the year 2021-22/2022;
- Attested copies by the Employer of 01 No. of 132kV Grid Station or Higher Voltage Level or Addition of Transformer in 132kV Grid Station, completed/energized successfully in last 05 years;
- Proof of registration with FBR for Sales Tax and Income Tax

Bidders may obtain further information from the Bidding Documents available on PPRA Punjab and/or FIEDMC websites. A complete set of Bidding Documents may be purchased by an interested bidder on submission of a written application duly attached with documents, stated here in above, from the office of the undersigned upon payment of a non-refundable fee of Rs. 10,000/- (Rupees Ten Thousand Only). Application for purchase of Bidding Documents with incomplete documents shall not be entertained. Bidding Documents shall not be issued on the Bid Submission Date.

The advertisement and Bidding Documents available on FIEDMC and PPRA Punjab website are for information only; interested bidder must purchase the bidding Documents from the office of the undersigned to ensure the completeness of the bidding documents and obtain any addendum, if issued by FIEDMC.

The Bids must be accompanied by an acceptable Bid Security (Bank Guarantee from Scheduled Bank in Pakistan/ CDR) in the name of FIEDMC. Any bid not accompanied by an acceptable Bid Security shall be declared non responsive. Any bid received by the Employer after the deadline for submission of bids will be returned unopened to such bidder.

In case of JV, the Lead Partner must fulfill the mandatory requirements stipulated in the Bidding Documents. Written application for purchase of Bidding Documents must also attach JV Agreement, as per PEC Standard Form of JV, on E Stamp Papers in addition to above stated mandatory documents.

Bidding Documents complete in all respects must be submitted at the address given below on or before the **22nd February 2022 at 1400 hrs.** Bids will be opened on the same date at **1500 Hrs.** in the presence of bidder's representatives who choose to attend at the below stated address. If the bid submission date is declared as public holiday, then bids submission date and opening of Bids shall be on the next working day.

The work will be awarded to the lowest evaluated bidder. Punjab Procurement Rules 2014, together with amendments, shall apply. Bids/ tenders with any condition shall be rejected. **(IPL-1035)**
